The Royal Zoological Society of SA (known as 'the Society' or Zoos SA), understands that when accessing our website or interacting with us online, at our shops, zoos, by telephone, or mail, the privacy and confidentiality of personal information is important to our members, volunteers, donors, sponsors and customers. As a result the Society is committed to safeguarding the personal information provided to us.

The Society will collect personally identifiable information in the following circumstances:- on you becoming a member, sponsor, donor to the Society; on participation in an event, program or activity conducted for the benefit of the Society; on expression of interest from you in receiving future communications from the Society.

The Society may use the personal information collected for the following purposes:- to provide information about events, programs and activities being undertaken by the Society; to raise funds for conservation programs undertaken or supported by the Society.

The Society will only share personal information with third parties in the following circumstances:- in order to provide the product or service requested; to send personal information to others that work on our behalf to provide a product or service to you; if legally required to do so; if otherwise required or permitted by the Privacy Act 1988.

The Society permits individuals to access their personal information in the following manner:- the request must be in writing; the Society will endeavour to respond in writing to requests for access within twenty eight days of the receipt of the request at the offices of the Society; the Society may impose a charge for providing access to the personal information depending on the nature of the request.

If a person wishes to alter personal information held by the Society, they should advise us in writing of the required changes.
